It is notified for information of all concerned that Hon'ble Vice Chancellor of this University has been pleased to constitute a Committee for Resources Assessment, Management and Mobilisation of this University with the following **Terms of Reference:**

The Resources Assessment, Management and Mobilisation Committee will note the present condition of the Water bodies, Farm House, Moveable & Immovable Properties (unused vehicles and log) of this University and initiate the followings:

- 1) Assembling of Moveable & immovable properties (including unused vehicles and log) in consultation with Forest Department as and when necessary.
- 2) Preparation of an Asset Database/Asset Register (in Standard Proforma) be made and maintained properly.
- 3) Exploring the possibility of resource generation for the development of this University viz. General Corpus, Asset Corpus, Alumni Corpus, International Corpus.
