The Eastern Regional Committee in its 167th ERC meeting held on 9th-10th January, 2014, after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. and reply dated 17.12.2013 in response to deficiency letter, the Committee discussed the matter in detail and decided as under:

- In the event of this office not receiving any representation within 30 days from the publication of the
  minutes in the ERC website, it will be presumed that you do not wish to make any representation and the
  Eastern Regional Committee shall take the decision, as it deems fit and proper under section 15(3)(b) of the
  NCTE Act, 1993.
- However, if the institution has already submitted the reply in response to uploaded minutes of 167th
  meeting of ERC in its Website, the same shall be treated as the reply to the decision of ERC.
