Minutes of the Meeting of the Anti Ragging Committee held on 18.05.2022 at the office chamber of the Hon'ble Vice Chancellor, the University of Burdwan.

- The Anti Ragging Committee considered the complaint vide complaint ID no. WB_0028 received from the Anti Ragging Help Line through E-mail dated 14.05.2022.
- The Anti Ragging Committee also noted that there is no complaint in this regard has been submitted to this University.
- The report of the Anti Ragging Squad against the complaint ID no. WB_0028 was read out.
- The committee also noted that subsequently the Registrar of the University, the Convener of the Anti Ragging Squad, Hostel Superintendent of Nivedita Hostel and Dr. Indrani Chandra, Teacher-in-Charge, Dept. of Bio-technology made a visit to the Nivedita Hostel in relation to the complaint.
- During the visit they met the borders and most specifically the 2nd year students who were residing in Nivedita Hostel to know from them about any such incident. The borders belonging to 2nd year informed the visiting team that no incident of ragging has occurred in the hostel. However, the members of the team thought it wise to sensitize the borders about the reparcation of ragging and advised the borders not to indulge any such activity.
- Based on the report submitted by the Anti Ragging Squad and observation made by the team visited the Nivedita Hostel on 17.05.2022, the Anti Ragging Committee after detail discussion resolved that the incident of ragging as mentioned in the complaint ID no. WB_0028 could not be established.

	iii)Few final year student-boarders (PG) available during the visit to hostel.
	The committee members interacted with the Mess Committee members of the hostel as well as with first and final year students who are staying in the hostel as boarders.
	During interaction the Mess committee members of the hostel as well as both the first and final year students denied about the occurrence of any such incident.
	Later, the members of Anti-Ragging Squad also Interrogated the students named in the complaint along with some senior students and they also denied occurrence of any incident of ragging.

Minutes of the Meeting of the Anti Ragging Squad held on 17.05.2022 at 5 p.m.

- On the basis of the E-mail received from Anti Ragging Help Line, the Vice Chancellor requested the Anti Ragging Squad to investigate the matter on urgent basis.
- The members of Anti Ragging Squad visited all the girl's hostels of this University on 14.05.2022. The members of the Anti Ragging Squad interacted with first year students, senior students as well as Mess Committee members. Based on the investigation the Anti Ragging Squad could identify that two students namely Ms. Suraiya Khatun and Ms. Riya Mondal are the borders of Nivedita Hostel. Ms. Suraiya Khatun is a student of 'Dept. of Women's Studies' and Ms. Riya Mondal is pursuing her studies in the 'Dept. of Education'. When interrogation both of them denied their involvement in any form of ragging against any border of the hostel.
- Based on the interaction it was found that on Thursday night i.e. on 12.05.2022 there was a General Body
 meeting of all the students staying in Nivedita Hostel and this meeting was held for the purpose of
 deciding modalities for arrangement of food and dining timing etc.
- In this meeting the borders belonging to 2nd year and 1st year were also introduced to each other. On 15.05.2022 the Anti Ragging Squad further interrogated both the students named in the complaint alongwith some other senior borders and all of them denied the occurrence of any incident of ragging in the Hostel premises.
- The identity of 'Selina' (mentioned in the complaint) could not be established neither as border of the any hostel nor any border could recognize /identify any such person staying in any hostel.
- Since the students named in the compliant were the borders of Nivedita Hostel, the Anti Ragging Squad
 in the presence of convener Anti Ragging Committee and Registrar decided to interact with all the 1st
 year students of Bengali Department, residing in Nivedita Hostel, since the complainant is mentioned as
 SCP Bengali post graduate 1st year in the complaint.
- It was found that there were altogether 7 (seven) students residing in the Nivedita Hostel who are pursuing 1st year of studies in Bengali.
- Convener Anti Ragging Committee along with Registrar and other members interacted with all seven students (individually) and all seven students denied any occurrence of ragging in the hostel premises.
 Hence, the committee could not identify the victim.
- During interrogation, when they were specifically asked about the behavior of the students named in the
 complaint i.e. Ms. Suraiya Khatun and Ms. Riya Mondal during the General Body meeting, all the 1st
 year students of Bengali reported that both the students named in the complaint were present in the
 meeting but their behaviour was cordial.

• Based on the interaction, the Anti Ragging Squad could not establish the occurrence of any incident of ragging in the hostel premises.
