#### MEMORANDUM

On the basis of recommendation made by the Union Public Service Commission vide letter No. F.1/58(11)/2021-R.II/SPC-I dated 05.12.2023, the Director General, Geological Survey of India is pleased to offer Shri/Smt./Ms. Sourav Bag (Roll: 1600029, Category: EWS) a PROVISIONAL appointment to the post of Assistant Chemist, a General Central Service Group 'B' Gazetted, Non-Ministerial post, in Pay Matrix Level- 08 in the Pay Scale of Rs. 47,600 – 1,51,100/- (As per 7th C.P.C.) in Geological Survey of India on the following terms and conditions:
